## June 12, 2012 Minutes

The Florence City Council met on June 12, 2012, with Mayor Mary Condon presiding and Council members Lesa Ragsdale, Kory Woolverton, Richard Rogers, Denise Deichmann, and Debra Bartos Cahill present.

Mayor Mary Condon called the meeting to order at 7:00 pm.

Denise Deichmann seconded Mayor Mary Condon asked to poll the Council.
