Staff members present: Amy L. Crane and Paul Mallini.


Guests present: Williamson County Emergency Management Personnel

Pledge of Allegiance was followed by a moment of silence.



6. Mayor Mary Condon adjourned the meeting at 6:09 pm.



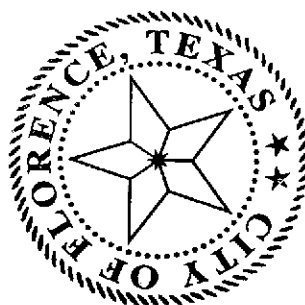


