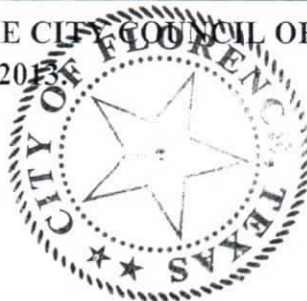


11. The next Council meeting is scheduled for Tuesday, October 1, 2013, at 6:00 pm.
