


PUBLIC HEARING NOTICE

NOTICE OF 2018 TAX YEAR PROPOSED PROPERTY TAX RATE FOR

City of Florence

A tax rate of \$0.643509 per \$100 valuation has been proposed by the governing body of City of Florence.

PROPOSED TAX RATE	\$0.643509 per \$100
PRECEDING YEAR'S TAX RATE	\$0.700000 per \$100
EFFECTIVE TAX RATE	\$0.643509 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for City of Florence from the same properties in both the 2017 tax year and the 2018 tax year.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

$$\text{property tax amount} = (\text{rate}) \times (\text{taxable value of your property}) / 100$$
