

RESOLUTION NO 05142019-01
Canvassing the May 4, 2019, Regular/Special Election

WHEREAS, in accordance with the general laws and Constitution of the State of Texas, the City Council ordered a Regular/Special Election for said election to be held on May 4, 2019. The Regular/Special Election was called for the purpose of electing three Council members at-large and two propositions; and

Proposition A

Shall the city be authorized to sell parkland property as described below under the provisions of section 253.001(b) of the Texas local government code: 104 Church Street, Florence, Texas (formerly City swimming pool) more particularly described as Lot 2 & Lot 3, Block 5, of the O.B. ATKINSON according to the map or plat thereof recorded in the Office of the County Clerk, Williamson County, Texas; SAVE & EXCEPT a tract of 0.03 acres conveyed by Deed dated September 5, 1984 of record in Volume 1069, Page 347, of the Official Records of Williamson County, Texas.

Proposition B

The reauthorization of the local sales and use tax in the City of Florence, Texas at the rate of one-fourth of one percent to continue providing revenue for maintenance and repair of municipal streets.

WHEREAS, the Judges and Clerks of said election have returned to the City Council of the City of Florence the official results (Exhibit "A") for the purpose of the official canvass; and

WHEREAS, the City Council on May 4, 2019, has canvassed the results for the purpose of determining the official election outcome; and

NOW, THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Florence, Texas that the official vote at the Regular Election held May 4, 2019, was as follows:
