WHEREAS, the City Council of the City of Florence, Texas owns certain real property and improvements locally as 304 East Main Street, Florence, Texas 76527, which is more particularly described as follows:

WHEREAS, the Council finds that it is in the best interest of the City to sell such Property and improvements; and

WHEREAS, the Council further finds it in the best interest of the City to sell the Property by sealed bids pursuant to Sec. 272.001, et seq, of the Texas Local Government Code.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FLORENCE, TEXAS:

- **SECTION 1.** The findings and recitations set out in the preamble of this Resolution are found to be true and correct and that they are hereby adopted by the City Council and made a part hereof for all purposes.
- **SECTION 2.** Before the Property may be sold, the Council finds that notice to the general public of the offer of the land for sale or exchange must be published in a newspaper of general circulation in the county in which the land is located. The notice must include a description of the land, including its location, and the procedure by which sealed bids to purchase the land or offers to exchange the land may be submitted. The notice must be published on two separate dates and the sale or exchange may not be made until after the 14th day after the date of the second publication.
- **SECTION 3.** The City Secretary of the City of Florence is hereby authorized and directed to cause notices of the sealed bid and procedure for submission to be published twice in the Williamson County Sun, a newspaper having general circulation in the City on two separate dates as required by law.
- **SECTION 4.** The City Secretary is further authorized and directed to publish and/or post, in the time and manner prescribed by law, all other notices required to be so published and/or posted in connection with such sealed bid process.

SECTION 5. Should any part, section, subsection, paragraph, sentence, clause or phrase contained in this Resolution be held to be unconstitutional or of no force and effect, such holding shall not affect the validity of the remaining portion of this Resolution, but in all respects said remaining portion shall be and remain in full force and effect.

RESOLUTION OF THE CITY OF FLORENCE, TEXAS, FINDING VOTER APPROVAL FOR SALE OF PARK OR POOL PROPERTY OWNED BY CITY; DETERMINING SALE OF PROPERTY BY SEALED BID IS IN THE BEST INTEREST OF THE CITY; AUTHORIZING AND DIRECTING CITY SECRETARY TO PUBLISH NOTICE OF THE REQUEST FOR SEALED BIDS AND OTHER NOTICES AS REQUIRED BY LAW; AND CONTAINING OTHER PROVISIONS NECESSARY AND INCIDENTAL TO THE PURPOSES HEREOF.

WHEREAS, Section 253.001(b) of the Texas Local Government Code authorizes the sale of parkland property by a city upon the submittal of the issue of the sale to the qualified voters of the City at an election and the approval of the issue by a majority of the votes received at the election; and

WHEREAS, the City Council of the City of Florence, Texas enacted Ordinance No. 003052019-03 on March 5, 2019, ordering an election of qualified voters of the City to approve or reject a proposition to authorize the sale of certain park/swimming pool property as described locally as 104 Church Street, Florence, Texas 76527, which is more particularly described as follows:

Lot 2 and Lot 3, Block 5, of the O.B. Atkinson (New) Addition to the City of Florence, Williamson County, Texas, according to the map or plat thereof recorded in the Office of the County Clerk of Williamson County, Texas; SAVE AND EXCEPT attract of 0.03 acres conveyed by Deed dated September 5, 1984 of record in Vol. 1069, Page 347, of the Official Records of Williamson County, Texas (the "Property"); and

WHEREAS, upon the giving of proper notice and pursuant to the procedures set forth in Ordinance No. 003052019-03 and in accordance with provisions of the Texas Election Code, the City held an election on May 4, 2019 at which qualified voters of the City voted to approve or reject the proposal to authorize the sale of parkland/swimming pool property as described herein; and

WHEREAS, at said election, the Council finds that the majority of votes received did approve the sale of the parkland/swimming pool property; and
