The public can participate in the telephonic/video meeting hosted through ZOOM. Please email me with a request for ID and password due to recent zoom bombings. acrane@florencetex.com


The public will be permitted to offer public comments telephonically as provided by the agenda and as permitted by the presiding officer during the meeting.
